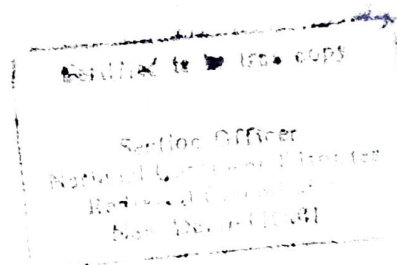

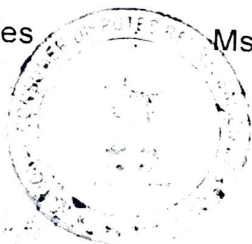

Learned counsel for the complainant submits, on instructions, that the complainant wishes to withdraw its complaint with liberty to revive it within thirty days by filing appropriate application.



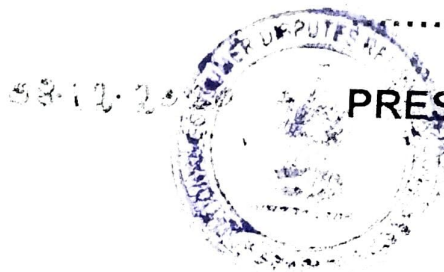
Learned counsel for the opposite parties submits, on instructions, that they will have no objection to the complaint being revived by the complainant.
